GENERAL REMARKS

Pursuant to Article 20 of the Constitution of the Republic of Türkiye and in accordance with Law No. 6698 on the Protection of Personal Data ("PDP Law"), personal data owners (hereinafter referred to as the "Applicant"), who are defined as data subjects, are entitled to apply to **ERNA MAŞ MAKİNA TİCARET VE SANAYİ ANONİM ŞİRKETİ** ("Company"), in its capacity as data controller, to exercise the rights set forth in Article 11 of the PDP Law concerning the processing of their personal data.

As stated in the first paragraph of Article 13 of the Law on the Protection of Personal Data (PDP Law): "The data subject shall submit his/her requests regarding the implementation of this Law to the data controller in writing or by other means to be determined by the Board," in accordance with the <u>Communiqué on the Procedures and Principles of Application to the Data Controller</u> published in the Official Gazette dated March 10, 2018 and numbered 30356; the data subject is required to submit their request to us through the specified methods.

D. Right of the Personal Data Owner (Data Subject) to File a Complaint with the Board

Pursuant to Article 14 of the Law on the Protection of Personal Data (PDP Law), if an application is rejected, the response is found to be insufficient, or no response is provided within the prescribed time, the data subject may file a complaint with the Board within thirty (30) days from the date of learning of our Company's response, and in any case, within sixty (60) days from the date of the application.

Please note that a complaint cannot be filed with the Board without first submitting an application to our Company.
